BHRC Roundtable event: This Wednesday, 30th May at 5:30pm the BHRC will be hosting a roundtable with Guatemalan human rights advocate Reverend José Pilar Alvarez, looking at how UK lawyers can support his organisation, the Association to Protect the Las Granadillas Mountain (APMG). As a result of this work on environmental protection, José Pilar and community leaders have suffered numerous threats and he has twice been the victim of spurious charges. Recent BHRC letters of concern and statements

Pakistan: BHRC expresses concern at the position of Pakistan's Ministry of Interior, which is blocking plans to raise the age of criminal responsibility in the Islamic Republic of Pakistan from 7 to 12 years.

Colombia: The Colombian Constitutional Court confirmed its decision regarding the suspension order made on Muriel Mining Corporation's Mandé Norte Project in

Chocó to explore and extract minerals on collectively owned Indigenous and Afro-Colombian land. In 2011 the BHRC submitted an [Amicus Curiae](#) to the Colombian Constitutional Court regarding the annulment of the decision taken by Colombia's Constitutional Court (7-769/2009) in the Muriel Mining Corporation Case. The brief deals with the international jurisprudence regarding the right to consultation and prior informed consent of the communities affected by large-scale projects.

Current BHRC scoping work

Malawi: Michelle Knorr and Rachel Logan are traveling to Malawi at the end of May with the purpose of conducting scoping work on behalf of the BHRC, thanks to the generous funding of the Scurrah Wainwright Charity. The BHRC delegates will be meeting with a number of individuals and organisations with the view to strengthening partnerships and building further channels of assistance for human rights work through the BHRC existing Public Interest Casework Support (PICS) project. In accordance with our mandate to monitor and uphold the rule of law, the BHRC frequently issues statements of concern and sends letters to raise attention about particular human rights violations. In 2010 and 2011, we intervened in a diverse number of human rights issues in Azerbaijan, Bahrain, Belarus, Colombia, Iraq, Jordan, Malawi, Mexico, Nepal, Pakistan, Rwanda, Uganda, Togo, Trinidad and Tobago, Turkey, different West African countries and Zimbabwe.
